February 2017 Newsletter

The month of February will start with the Field Training Unit organised Army Weapons Effect Simulation Exercise WESSEX STORM for light protective mobility infantry role which will use extensive areas across the Plain. This exercise will involve the use of Foxhound and Husky wheeled armoured vehicles and will be supported by elements of a light cavalry squadron in CVRT. The exercise will finish on 20 Feb 17. The final week of the month will host 3 heavy engineer squadrons and 2 warrior companies moving from the east to the west of the Plain. The public should be aware that tank crossings and bridge crossings over the A360, A345, A338, B390, and the C22 (Tilshead to Chitterne) roads will be very busy and if conditions are wet mud clearance parties will be working on the crossings. Notice is also given that the training areas in the Copehill Down and Bourne Valley (SPTA East) areas will be heavily used over this period and that recreational use of the Salisbury Plain military lands in these areas are to be restricted to public rights of way only as per the byelaws.

Note: NOTICE TO ALL DOG WALKERS

In the recent weeks there have been two serious incidents involving dogs on SPTA, both due to walkers not keeping them under control. The first was a dog had strayed into an out of bounds area where there was hazardous military training infrastructure, the dog injured itself quite severely as a result. The second was a dog had broken into a temporary penning and killed one sheep and severely wounded another. (The latter was destroyed).

Dog walkers are reminded that in accordance with Salisbury Plain Byelaws 1981 : No person when on the Military Lands shall fail to keep under control any dog or animal.

ACCESS

Access to SPTA is regulated by Salisbury Plain Military Lands, Bulford, Larkhill and Imber Range Byelaws. Always comply with local signs and flags. Rights of way in Range Danger Areas are closed when red flags are flying.

This Newsletter is published up to 6 weeks before the event and changes may occur. Access timings for the next week can be found on the SPTA Walks Line: (01980) 674763.

Imber Ranges. The public are excluded except when the roads are specifically opened. Planned open dates for 2017 are as follows:

WHAT CAN YOU DO TO REDUCE CRIME ON SALISBURY PLAIN?

If any crime is taking place call 999, (or 101) and do not under any circumstances challenge the offenders.

The new Rural Crime Partnership for Wiltshire and Swindon (hereafter 'the Rural Crime Partnership') has been established by Wiltshire Police in consultation with the Police and Crime Commissioner (PCC) for Wiltshire and Swindon to provide governance for, and oversee delivery of, rural crime strategy. It provides coherence, direction and guidance to

the delivery and apportionment of rural policing resources across the county in the context of the Community Policing Model. The first meeting was held at Wiltshire Police Headquarters on 18th October 2016; this is seen by Headquarters SPTA as a positive initiative in order to prevent crime and anti-social behaviour on Salisbury Plain.
